Roll call was taken and there was a quorum present.

NJ A1559/5902

A hearing has been scheduled for Monday, May 9th. The Division of Consumer Affairs has circulated revised language. T. Moore sent to all members a copy via email today. He encouraged all members to read the new language carefully and provide comments to him prior to the hearing on Monday. T. Moore noted we are working with our lobbyist to push for additional language changes. We are still not satisfied with the disclosure requirement when using the word "warranty". Haley noted AIG, SCIC & NHSCA all have lobbyist on the ground addressing the issue.

GA-GAC33-7-6(3)E

T. Moore informed members the GA DOI recently denied a bond approval due to preexisting condition language in the contract form. It is the opinion of T. Moore that It is apparently an overreach as it pertains to the statutory rules. Tretter with Choice HW noted they filed a contract that has not been approved and West with APHW noted he was told by the GA DOI that they will be reviewing service contracts for compliance with insurance exemptions and will treat anything not strictly complaint as insurance. Moore requested members let him know if anyone runs in to an issue. The NHSCA does not want to create a situation when there isn't any therefore no action will be taken at this time.

TN HB2114

T. Moore continues to reach out to the sponsor to get more information on this recent bill that was passed. The language is a bit odd. It adds language to the TCPA prohibiting advertising of a home warranty to consumers without explicitly stating in writing what items will be covered and fully paid for by the home warranty.

Arizona - R20-6-407

T. Moore informed members a public hearing has been set for June 14 @ 10:00 a.m.

Utah HB31

Auto renewal bill. The bill amends the insurance code where it requires disclosures for service Contracts Effective 5/3/2022.

MI HB5933

Auto renewal law added to the Consumer Protection Act requiring disclosure of cancellation method. Introduced in March 2022 and assigned to committee, but no action has been taken.

PA HB2511

Auto renewal law added to the Unfair Trade Practices and Consumer Protection Act. Introduced and referred to committee April 2022 with no further action.
