During the 2015 Regular Legislative Session, the filing of Home Service Contract Providers in Louisiana was transferred from the Louisiana Department of Insurance to the Louisiana Secretary of State. This change becomes effective January 15, 2016. In an effort to make a smooth transition, enclosed are the forms necessary for registering the Home Service Contract Provider Application with our office.

You will note on the enclosed forms that in addition to the application for filing, a copy of the organizational documents, a surety bond issued by a company licensed to do business in Louisiana in the amount of \$50,000 and the filing fee of \$600 are required. The provider must be registered with the Secretary of State and in good standing status.

The registration is effective for two years. The renewal application, surety bond issued by a company licensed to do business in Louisiana in the amount of \$50,000 and renewal fee of \$250 must be submitted to this office ninety days prior to the deadline.

Changes to the registration form can be made by filing an amended registration, accompanied by supporting documentation within 60 days of the effective date of the change. In addition to any amendments, R.S. 57:3143 requires that a financial statement showing that the provider is solvent must be submitted to the Secretary of State's office annually. Lastly, a Home Service Contract report must be provided by March 1st of every year documenting the following for the previous year: the number of home service contracts issued or sold with respect to residential property; the gross consideration received; the number and dollar amount of claims paid categorically by the cost of repair or by the cost of replacement; and the number of claims denied for failure of the service contract holder to receive prior approval for such repair or replacement. There is no fee for filing the amendment, financial statement or Home Service Contract Report.

The initial registration form must be completely filled out and submitted to the Secretary of State's office along with a copy of its organizational documents (Articles of Incorporation, Articles of Organization, Articles of Association, Partnership Agreement), a surety bond issued by a company licensed to do business in Louisiana in the amount of \$50,000 and the filing fee of \$600.
- 2. The provider must be registered with the Louisiana Secretary of State's office and must be in good standing.
- 3. The registration is effective for two years. The renewal date is January 15th. The renewal application must be submitted to the Secretary of State's office, along with a surety bond issued by a company licensed to do business in Louisiana in the amount of \$50,000, ninety days prior to the deadline. The renewal registration fee is \$250.
- 4. Changes to the registration form can be made by filing an amended registration, accompanied by supporting documentation (amendments to the Articles of Incorporation, Articles of Organization, Articles of Association or Partnership Agreement), with the Secretary of State's office within 60 days of the effective date of the change. If the amendment is not due to any changes to the organizational documents, a statement to the fact can be submitted. There is no fee to amend the registration.
